

ORDINANCE NO. 2025-04

**ORDINANCE LEVYING AND ASSESSING TAXES OF
BYRON FIRE PROTECTION DISTRICT
OGLE COUNTY, ILLINOIS FOR 2025**

BE IT ORDAINED by the Board of Trustees of the Byron Fire Protection District, Ogle County, Illinois, as follows:

Section One: That the sum of four million five-hundred sixty-four thousand DOLLARS (\$4,564,000.00) be assessed and levied from and against all taxable property within the limits of the said Byron Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2025. The specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

CORPORATE FUND

AMOUNT TO BE RAISED BY TAX LEVY:

Corporate Fund Levy \$1,936,000.00

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$1,738,000.00

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

TORT FUND

Tort Fund Levy \$ 470,000.00

The foregoing amount is hereby levied for tort expense purposes pursuant to the provisions of 745 ILCS 10/9-107.

FIREFIGHTER PENSION FUND

Firefighter Pension Fund Levy \$ 420,000.00

The foregoing amount is hereby levied for firefighters' pension fund pursuant to the provisions of 40 ILCS 5/4-118.

Section Two: That the Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk of Ogle County within the time specified by law.

Section Three: If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of remaining portions of the Ordinance.

Section Four: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
